**Overflow/Switcher Tax Credit Donations**

After donating the maximum amount allowed under the Original Tax Credit, all donated amounts are applied to the Overflow/Switcher Tax Credit. The Original Tax Credit amount donated to any School Tuition Organization(STO) must be claimed as an Arizona tax credit on Arizona Tax Form 323 and including that form with the taxpayers Arizona Income Tax Return. Additional amounts donated to an STO should be claimed on Arizona Tax Form 348. No credit should be claimed on a Form 348 until the maximum credit amount is claimed on Form 323.
